### WHO WE ARE...

We are a registered charity and company limited by guarantee. We were set up in 2005 to continue the work of the Ackers Trust.

The Trust was originally established in 1981 to provide outdoor educational, recreational and environmental activities for the benefit of the whole community, especially children and young people.

Today the Ackers Trust site is managed in 3 zones. Ackers Trust still exists to ensure that any developments are in keeping with the Trust deed on the land. Ackers Adventure has a 125 year lease on the centre part of the site and the front and rear parts are managed by Birmingham City Council.

We currently offer the widest range of outdoor educational activities on any one site in the Midlands. These include dry slope skiing, snowboarding, tobogganing, canoeing, climbing, bell boats, disc golf, archery, bushcraft, orienteering, team building, and a 20m tower with abseiling, a fan descender and zip wires. As well as running activity based courses. There is also a self-catering residential centre and meeting rooms available to hire. The centre is registered with the relevant National Governing Bodies.

We employ 12 full and part time staff and up to 20 casual staff who are all DBS checked. It has over 250 volunteers each year from companies, work experience and community payback schemes which all help to maintain the environmental aspect of the site.

We have a Board of Director/Trustees who meet monthly with the CEO and senior staff team. It is funded by a combination of charges to participants and fundraising for some capital and project spending. As well as individuals, customers include schools, children in care, alternative provision, youth clubs and other community groups. The activities contribute not just to health, fitness and wellbeing but also for the personal development of young people.


